Introduction

Since its inception, Mark Oliphant College has proudly maintained a tradition of providing the latest technology to all learners from Birth to Year 12. This commitment enables students to develop the ICT capabilities required to use technology effectively and become responsible digital citizens both at and beyond school.

College Chromebook Co-Contribution Program

Students in Years 9 to 12 at Mark Oliphant College have the opportunity to purchase a new Chromebook through the College for use both at school and beyond. To participate, students must provide a signed acknowledgement of the College ICT User Agreement and a signed 'Commitment to Pay' form.

The ICT User Agreement outlines the responsibilities of students to safely care for and use the Chromebook while enrolled at the College. The 'Commitment to Pay' form signifies an agreement to contribute a total of \$400 towards the cost of the Chromebook, payable in four annual instalments of \$100 at the commencement of Years 9, 10, 11, and 12.

The College subsidises the remaining cost of the Chromebook and covers the expense of Accidental Damage and Protection (ADP) insurance for each device. The total cost of a new Chromebook with ADP is approximately \$850.

Bring Your Own Device (BYOD) Program

The school supports students who wish to use their own laptops through the Bring Your Own Device (BYOD) program. To ensure safe and effective operation on the College network, BYOD devices must meet the specified minimum to recommended specifications. Approval requests for BYOD devices can be submitted through Student Services.

TERMS OF THE AGREEMENT

By signing this agreement I understand that:

1. The Mark Oliphant College Laptop Program is optional.
2. Laptops are to be used by students in accordance with the College ICT User Agreement.
3. The laptop remains the property of the school for student's educational use until such a time that it is fully paid off.
4. Laptops for year 7 and 8 students are to remain at school at all times and stored and locked in trolleys overnight.
5. Students in year 9-12 may take their laptops home overnight and are expected to come to school with their laptop fully charged each school day.
6. As a Year 7 or Year 8 Student I understand that signing the agreement constitutes a commitment to pay:
 - (a) \$100 Security Deposit
 - (b) That this deposit is 'rolled over' at the end of the school year when the laptop is returned undamaged and in a similar condition to when it was issued.
7. As a Year 9 through to Year 12 Student I understand that signing the agreement constitutes a commitment to pay:
 - a) \$100 co-contribution to the Mark Oliphant Laptop Program in each year of the year 9 to 12 schooling years.
8. The laptop will be fully owned by the students when 4 x \$100 payments from Years 9 through to Year 12 have been fully paid.
9. Where payment has not been received by the due dates specified that the Mark Oliphant College School's debt recovery policy will apply.
10. Payments can be made via the QKR app or the MOC Finance Office.
